## Maintenance & Operation Instructions

### NOZZLE COMES FACTORY INSTALLED. TO ACCESS THE NOZZLE:




1 Squeeze tabs on the side of the plate assembly and pull.



2 Inspect the 7TN nozzle for plugging or damage. Replace if necessary.



3 Reinstall plate assembly. Guide shift lever between stops as shown in Fig. 4.



4 Make sure shift lever is between stops as shown. Adjust stops to give desired arc of coverage



The R75M Debris Sweeping Sprinkler requires a rigid inlet pipe, at least 6" long.
